PCI COMPLIANCE

The Payment Card Industry Security Standards Council (PCI SSC) created the Payment Card Industry Data Security Standard (PCI DSS), which consists of a set of controls that prescribe operational and technical controls to protect cardholder data. Merchants must first become compliant and then remain compliant. The Compliance portal can help reduce the costs of ongoing compliance and audits

TRANSIT AND PCI COMPLIANCE

If your transit agency is accepting credit cards from patrons for the purchase of transit fares, then you need to be PCI compliant. This includes acceptance of credit cards at Ticket Vending Machines, Agency operated sales offices, web sites, telephone and mail order, customer service or any distribution channel used. As a Merchant you are subject to PCI compliance from the brand payment vendors (such as VISA, MasterCard, AMEX, Discover, etc...) and can be subject to fines for non-compliance. Levels of compliance are set based on the volumes of credit and debit card transactions performed annually.

Some transit agencies have spent millions of dollars to become compliant, only to fall out of compliance within a year. This is primarily due to not having the proper tools to manage a PCI compliance program.
